Principal investigator in a standard grant awarded by the Social Sciences and Humanities Research Council of Canada. “Neighbourhood Influences on the Developmental Trajectories of Children and Youth” (co-investigators are Ann-Marie Sorenson and Lorne Tepperman). \$87,000 over three years from May, 2003.

Principal investigator in several contracts with the Applied Research Branch of Human Resources Development Canada, (HRDC) for analysis of the National Longitudinal Survey of Children and Youth. (1) “Gender Differences in Developmental Trajectories.” \$24,000. Awarded November, 2002. (2) “Potential Longitudinal Analytic Methods for the NLSCY Based on Seminal Work with Other Longitudinal Surveys.” \$24,000. Awarded October, 2002. (3) “The Impact of Neighborhood Social Capital and Family Stress on Child Health and Learning Outcomes in Canada.” \$24,000. Final Report submitted March 31, 2002 and in the process of publication by HRDC. I have completed analysis of NLSCY Cycles 1 to 3 in the Statistics Canada Research Data Centre and am continuing to work with the public use files from the same survey.

Co-investigator and team leader in the Univ. of Toronto group working with five other universities on the project, “Canadian Century Research Infrastructure.” Some \$13 million in funding from the Canadian Foundation for Innovations was announced early in

2002. This project will construct microdata files created from Census enumerations from the later 19th to the mid-20th centuries. The principal investigator is Professor Chad Gaffield of the University of Ottawa.

Co-investigator and team member in the Univ. of Toronto group of geographers and sociologists that received some \$1.9 million from the Canadian Institutes of Health Research in the fall of 2003 the “Canadian Urban Health Institute” project. The principal investigator is Professor John Myles of the University of Toronto and Statistics Canada.

I am carrying out data analysis relevant to the “individualization thesis”, using Canadian sources such as the Adult Education and Training Survey, the various cycles of the General Social Survey and the Census of Canada, as well as the British Household Panel Survey and the Census Longitudinal Survey (the CeLSius project)

Current Teaching

I regularly teach courses on Social Statistics (undergraduate and graduate), Sociology of the Family (undergraduate) and Social Mobility (undergraduate). Two recently developed courses are Historical Methods (Census Data) and Longitudinal Surveys. I have converted all my courses to PowerPoint and make the slides available to students.
